24 AND RECEIVE A REFERRAL TO A SUBSTANCE ABUSE TREATMENT FACILITY.

27 A COUNTY THAT RECEIVES 911 TELEPHONE CALLS SHALL REPORT TO THE

35 A. Any person who, pursuant to a scheme or artifice to defraud,
36 knowingly obtains any benefit by means of false or fraudulent pretenses,
37 representations, promises or material omissions is guilty of a class 2
38 felony.

39 B. Reliance on the part of any person shall not be a necessary
40 element of the offense described in subsection A of this section.

41 C. A person who is convicted of a violation of this section that
42 involved a benefit with a value of one hundred thousand dollars or more OR
43 THE MANUFACTURE, SALE OR MARKETING OF OPIOIDS is not eligible for
44 suspension of sentence, probation, pardon or release from confinement on
45 any basis except pursuant to section 31-233, subsection A or B until the

1 sentence imposed by the court has been served, the person is eligible for
2 release pursuant to section 41-1604.07 or the sentence is commuted.

3 D. ~~The~~ THIS state shall apply the aggregation prescribed by section
4 13-1801, subsection B to violations of this section in determining the
5 applicable punishment.

6 E. ~~As used in~~ FOR THE PURPOSES OF this section, "scheme or artifice
7 to defraud" includes a scheme or artifice to deprive a person of the

10 by adding section 13-3423, to read:

11 13-3423. Medical assistance requests; prohibited prosecution
12 of Good Samaritans; mitigating factor; definitions

13 A. A PERSON WHO, IN GOOD FAITH, SEEKS MEDICAL ASSISTANCE FOR
14 SOMEONE EXPERIENCING A DRUG-RELATED OVERDOSE MAY NOT BE CHARGED OR
15 PROSECUTED FOR THE POSSESSION OR USE OF A CONTROLLED SUBSTANCE OR DRUG
16 PARAPHERNALIA OR A PREPARATORY OFFENSE IF THE EVIDENCE FOR THE VIOLATION
17 WAS GAINED AS A RESULT OF THE PERSON'S SEEKING MEDICAL ASSISTANCE.

18 B. A PERSON WHO EXPERIENCES A DRUG-RELATED OVERDOSE, WHO IS IN NEED
19 OF MEDICAL ASSISTANCE AND FOR WHOM MEDICAL ASSISTANCE IS SOUGHT PURSUANT
20 TO SUBSECTION A OF THIS SECTION MAY NOT BE CHARGED OR PROSECUTED FOR THE
21 POSSESSION OR USE OF A CONTROLLED SUBSTANCE OR DRUG PARAPHERNALIA IF THE
22 EVIDENCE FOR THE VIOLATION WAS GAINED AS A RESULT OF THE PERSON'S OVERDOSE
23 AND NEED FOR MEDICAL ASSISTANCE.

24 C. THE ACT OF SEEKING MEDICAL ASSISTANCE FOR SOMEONE WHO IS
25 EXPERIENCING A DRUG-RELATED OVERDOSE MAY BE USED AS A MITIGATING FACTOR IN
26 A CRIMINAL PROSECUTION FOR A VIOLATION OF THIS CHAPTER.

27 D. THIS SECTION DOES NOT LIMIT EITHER:

28 1. THE ADMISSIBILITY OF ANY EVIDENCE IN CONNECTION WITH THE
29 INVESTIGATION OR PROSECUTION OF A CRIME WITH REGARD TO A DEFENDANT WHO
30 DOES NOT QUALIFY UNDER SUBSECTION A OR B OF THIS SECTION OR WITH REGARD TO
31 ANY OTHER CRIME.

32 2. THE ABILITY TO SEIZE CONTRABAND OR MAKE AN ARREST FOR ANY OTHER
33 OFFENSE.

34 E. THIS SECTION DOES NOT PROHIBIT A PERSON SPECIFIED IN SUBSECTION
35 A OR B OF THIS SECTION FROM BEING OFFERED A DIVERSION PROGRAM FOR AN
36 OFFENSE OTHER THAN THE POSSESSION OR USE OF A CONTROLLED SUBSTANCE OR DRUG
37 PARAPHERNALIA OR A PREPARATORY OFFENSE.

38 F. FOR THE PURPOSES OF THIS SECTION:

39 1. "MEDICAL ASSISTANCE" MEANS AID PROVIDED BY A HEALTH CARE
40 PROFESSIONAL WHO IS LICENSED, REGISTERED OR CERTIFIED IN THIS STATE, WHO
41 IS ACTING WITHIN THE HEALTH CARE PROFESSIONAL'S SCOPE OF PRACTICE AND WHO
42 PROVIDES A DIAGNOSIS, TREATMENT OR OTHER MEDICAL SERVICE.

43 2. "SEEKS MEDICAL ASSISTANCE" MEANS TO CALL 911 OR OTHERWISE
44 CONTACT LAW ENFORCEMENT, POISON CONTROL OR A HOSPITAL EMERGENCY
45 DEPARTMENT.

1 (b) INCLUDES THE PROVISION OF A PRESCRIPTION DRUG, DEVICE OR
2 DURABLE MEDICAL EQUIPMENT FOR THE TREATMENT OR MANAGEMENT OF ACUTE PAIN,
3 CHRONIC PAIN OR OPIOID USE DISORDER.

4 (c) DOES NOT INCLUDE TREATMENTS THAT ARE EXPERIMENTAL,
5 INVESTIGATIONAL OR OFF LABEL.

6 7. "HEALTH CARE SERVICES PLAN":

7 (a) MEANS A PLAN OFFERED BY A DISABILITY INSURER, GROUP DISABILITY
8 INSURER, BLANKET DISABILITY INSURER, HEALTH CARE SERVICES ORGANIZATION,
9 HOSPITAL SERVICE CORPORATION OR MEDICAL SERVICE CORPORATION THAT
10 CONTRACTUALLY AGREES TO PAY OR MAKE REIMBURSEMENTS FOR HEALTH CARE
11 SERVICES EXPENSES FOR ONE OR MORE INDIVIDUALS RESIDING IN THIS STATE.

12 (b) DOES NOT INCLUDE BENEFITS PROVIDED UNDER LIMITED BENEFIT
13 COVERAGE AS DEFINED IN SECTION 20-1137.

14 8. "MEDICALLY NECESSARY" OR "MEDICAL NECESSITY":

15 (a) MEANS COVERED HEALTH CARE SERVICES PROVIDED BY A LICENSED
16 PROVIDER ACTING WITHIN THE PROVIDER'S SCOPE OF PRACTICE IN THIS STATE TO
17 PREVENT OR TREAT DISEASE, DISABILITY OR OTHER ADVERSE CONDITIONS OR THEIR
18 PROGRESSION OR TO PROLONG LIFE.

19 (b) DOES NOT INCLUDE SERVICES THAT ARE EXPERIMENTAL OR
20 INVESTIGATIONAL OR PRESCRIPTIONS THAT ARE PRESCRIBED OFF LABEL.

21 9. "MEDICATION-ASSISTED TREATMENT" HAS THE SAME MEANING PRESCRIBED
22 IN SECTION 32-3201.01.

23 10. "PRIOR AUTHORIZATION REQUIREMENT":

24 (a) MEANS A PRACTICE IMPLEMENTED BY A HEALTH CARE SERVICES PLAN OR
25 ITS UTILIZATION REVIEW AGENT IN WHICH COVERAGE OF A HEALTH CARE SERVICE IS
26 DEPENDENT ON AN ENROLLEE OR A PROVIDER OBTAINING APPROVAL FROM THE HEALTH
27 CARE SERVICES PLAN BEFORE THE SERVICE IS PERFORMED, RECEIVED OR
28 PRESCRIBED, AS APPLICABLE.

29 (b) INCLUDES PREADMISSION REVIEW, PRETREATMENT REVIEW, PROSPECTIVE
30 REVIEW OR UTILIZATION REVIEW PROCEDURES CONDUCTED BY A HEALTH CARE
31 SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT BEFORE PROVIDING A HEALTH
32 CARE SERVICE.

33 (c) DOES NOT INCLUDE CASE MANAGEMENT OR STEP THERAPY PROTOCOLS.

34 11. "PROVIDER" MEANS A PHYSICIAN, HEALTH CARE INSTITUTION OR OTHER
35 PERSON OR ENTITY THAT IS LICENSED OR OTHERWISE AUTHORIZED TO FURNISH
36 HEALTH CARE SERVICES IN THIS STATE.

37 12. "URGENT HEALTH CARE SERVICE" MEANS A HEALTH CARE SERVICE WITH
38 RESPECT TO WHICH THE APPLICATION OF THE TIME PERIODS FOR MAKING A
39 NONEXPEDITED PRIOR AUTHORIZATION DECISION, IN THE OPINION OF A PROVIDER
40 WITH KNOWLEDGE OF THE ENROLLEE'S MEDICAL CONDITION, COULD EITHER:

41 (a) SERIOUSLY JEOPARDIZE THE LIFE OR HEALTH OF THE ENROLLEE OR THE
42 ABILITY OF THE ENROLLEE TO REGAIN MAXIMUM FUNCTION.

43 (b) SUBJECT THE ENROLLEE TO SEVERE PAIN THAT CANNOT BE ADEQUATELY
44 MANAGED WITHOUT THE CARE OR TREATMENT THAT IS THE SUBJECT OF THE
45 UTILIZATION REVIEW.

1 20-3404. Prior authorization requirement timelines

2 A. IF A PLAN OFFERED BY A HEALTH CARE SERVICES PLAN CONTAINS A
3 PRIOR AUTHORIZATION REQUIREMENT, ALL OF THE FOLLOWING APPLY:

4 1. FOR PRIOR AUTHORIZATION REQUESTS CONCERNING URGENT HEALTH CARE
5 SERVICES, THE HEALTH CARE SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT
6 SHALL NOTIFY THE PROVIDER OF THE PRIOR AUTHORIZATION OR ADVERSE
7 DETERMINATION NOT LATER THAN FIVE DAYS AFTER THE RECEIPT OF ALL NECESSARY
8 INFORMATION TO SUPPORT THE PRIOR AUTHORIZATION REQUEST.

9 2. FOR PRIOR AUTHORIZATION REQUESTS CONCERNING HEALTH CARE SERVICES
10 THAT ARE NOT URGENT HEALTH CARE SERVICES, THE HEALTH CARE SERVICES PLAN OR
11 ITS UTILIZATION REVIEW AGENT SHALL NOTIFY THE PROVIDER OF THE PRIOR
12 AUTHORIZATION OR ADVERSE DETERMINATION NOT LATER THAN FOURTEEN DAYS AFTER
13 RECEIPT OF ALL NECESSARY INFORMATION TO SUPPORT THE PRIOR AUTHORIZATION
14 REQUEST.

15 3. ON RECEIPT OF INFORMATION FROM THE PROVIDER IN SUPPORT OF A
16 PRIOR AUTHORIZATION REQUEST, THE HEALTH CARE SERVICES PLAN OR ITS
17 UTILIZATION REVIEW AGENT SHALL PROVIDE A RECEIPT IN THE SAME FORMAT THAT
18 THE REQUEST WAS MADE TO THE PROVIDER ACKNOWLEDGING THAT THE INFORMATION
19 WAS RECEIVED, UNLESS THE NECESSARY RETURN CONTACT INFORMATION IS NOT
20 PROVIDED.

21 B. THE NOTIFICATION REQUIRED UNDER SUBSECTION A OF THIS SECTION
22 SHALL STATE WHETHER THE PRIOR AUTHORIZATION REQUEST IS APPROVED, DENIED OR
23 INCOMPLETE. IF THE PRIOR AUTHORIZATION REQUEST IS DENIED, THE HEALTH CARE
24 SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT SHALL STATE THE SPECIFIC
25 REASON FOR THE DENIAL. FOR A REQUEST THAT IS CONSIDERED INCOMPLETE, THE
26 PROVIDER SHALL HAVE THE OPPORTUNITY TO SUBMIT ADDITIONAL INFORMATION.
27 ONCE THE PROVIDER SUBMITS ADDITIONAL INFORMATION ON INCOMPLETE REQUESTS,
28 THE HEALTH CARE SERVICES PLAN HAS FIVE DAYS TO REVIEW AND RESPOND TO
29 REQUESTS FOR HEALTH CARE SERVICES DEEMED URGENT AND FOURTEEN DAYS TO
30 REVIEW AND RESPOND TO REQUESTS FOR HEALTH CARE SERVICES DEEMED NOT URGENT.

31 C. A PRIOR AUTHORIZATION REQUEST IS DEEMED GRANTED IF A HEALTH CARE
32 SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT FAILS TO COMPLY WITH THE
33 DEADLINES AND NOTIFICATION REQUIREMENTS OF THIS SECTION.

34 D. A PRIOR AUTHORIZATION REQUEST, ONCE GRANTED OR DEEMED GRANTED,
35 IS BINDING ON THE HEALTH CARE SERVICES PLAN, MAY BE RELIED ON BY THE
36 ENROLLEE AND PROVIDER AND MAY NOT BE RESCINDED OR MODIFIED BY A HEALTH
37 CARE SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT AFTER THE PROVIDER
38 RENDERS THE AUTHORIZED HEALTH CARE SERVICES IN GOOD FAITH AND PURSUANT TO
39 THE AUTHORIZATION UNLESS THERE IS EVIDENCE OF FRAUD OR MISREPRESENTATION
40 BY THE PROVIDER.

41 E. ON A DENIAL OF A PRIOR AUTHORIZATION REQUEST, THE ENROLLEE AND
42 THE PROVIDER MAY EXERCISE THE REVIEW AND APPEAL RIGHTS SPECIFIED IN
43 CHAPTER 15, ARTICLE 2 OF THIS TITLE.

1 20-3405. Prior authorization of prescription drugs for
2 chronic pain conditions

3 A. FOR A PRIOR AUTHORIZATION REQUEST RELATED TO A CHRONIC PAIN
4 CONDITION, THE HEALTH CARE SERVICES PLAN OR ITS UTILIZATION REVIEW AGENT
5 SHALL HONOR A PRIOR AUTHORIZATION THAT IS GRANTED FOR AN APPROVED
6 PRESCRIPTION DRUG FOR THE EARLIEST OF THE FOLLOWING:

- 7 1. SIX MONTHS AFTER THE DATE OF THE PRIOR AUTHORIZATION APPROVAL.
8 2. THE LAST DAY OF THE ENROLLEE'S COVERAGE UNDER THE PLAN.

9 B. IN RELATION TO A PRIOR AUTHORIZATION DESCRIBED IN SUBSECTION A
10 OF THIS SECTION, THE HEALTH CARE SERVICES PLAN OR ITS UTILIZATION REVIEW
11 AGENT MAY REQUEST THAT THE PROVIDER SUBMIT INFORMATION TO THE HEALTH CARE

33 implementation of electronic prescribing tools

34 On or before September 1, 2018, the director of the Arizona state
